Prescribed Tender Form alongwith Terms and Conditions for submission of Tender can be obtained from the Manager, Govt. of India Press, Ring Road, Mayapuri, New Delhi-110064 @ Rs. 50/- per set (Non-refundable) on any working day (Monday to Friday) during office hours from **21.11.2011 to 08.12.2011** and upto 12.00 Noon on **08.12.2011**.

1. Closing date and time for receipt of Tender - 08.12.2011 upto 3.00 P.M.
2. Opening date and time of Tender - 08.12.2011 at 3.30 P.M.
3. Rate should be quoted for the following items of work.
4. Carriage of consignment of all types of stores from Govt. of India Press, Ring Road, Mayapuri, New Delhi-110064 to other places located in the Territory of Delhi/New Delhi and also in N.C.R. area and vice-versa for consignment weightage:-

(i) Above 5 Quintal.

NOTE:- The Transportation Charges to be quoted should include Loading, Un-loading and Stacking of the Material at appropriate place.

5. The Tenderer will have to furnish an **Earnest Money of Rs. 6000/- (Rupees Six thousand only)** alongwith the Tender. The successful Tenderer will be required to furnish **Security deposit of Rs. 15,000/- (Rupees Fifteen thousand only) in one of the approved Form.**
6. The approximate value of the Contract would be **Rs. 1,40,000 (Rupees One Lac. forty thousand only)** tentative.
7. The Tender should be sent in Double Sealed Cover subscribed '**Tender for Transportation Work**' and addressed to the Manager, Govt. of India Press, Ring Road, Mayapuri, New Delhi so as to reach him by 3.00 P.M. on **08,12,2011 in 2-BID SYSTEM (in bold letters)** in separate Double Sealed Covers - One containing **E.M.D.** in proper Form and the other containing **PRICE BID.** Both the Covers have to be subscribed with Tender Number, its date of opening, Name of Tenderer. These **Two Covers** should be put in **One Main Sealed Cover** which should also be subscribed with Tender Number, Opening Date and Name of Tenderer. In case the envelope/cover containing E.M.D. /Income Tax Clearance Certificate, which will be opened first is found without **I.T.C.C./E.M.D. or E.M.D.** not in proper Form then the envelope containing **PRICE BID** will not be opened at all and that offer will automatically stand rejected.
